- Motion by Bob Berube to approve minutes from the January 29, 2015 meeting #1, seconded by Gerry Yake. Unanimous approval.
- Motion by Gerry Yake to approve minutes from the January 29, 2015 meeting #2, seconded by Lynne Woodman. Unanimous approval

#### **Business:**

#### Approval of Expenditures –

- Maintaining the Association website (RosedaleHD2.com) with 1&1 Internet Inc. incurs costs of \$104.76 annually, billed in quarterly installments of \$26.19. Motion made by Bob Berube to approve, seconded by Lynne Woodman and unanimously approved.
- Annual corporate filing of the Association with the State of Florida is \$70.00 per year.
   Motion made to approve by Lynne Woodman, seconded by Gerry Yake and unanimously approved.
- The Association has 139 palm trees of height requiring pruning. Discussion was held as to whether pruning should be done once or twice per year with a decision to try and hold to one pruning annually. Motion made by Bob Berube to approve \$2,024.00 to Teal Lawn Inc. for pruning of 139 palm trees to be done in May 2015. Motion seconded by Lynne Woodman and unanimously approved.
- Teal Lawn Inc. submitted an invoice of \$15.00 for irrigation system repairs at 9745 51<sup>st</sup>
   Terrace East. Motion made to approve by Bob Berube, seconded by Reon Onstine and unanimously approved.

# Other Business and Open Discussion

Gerry Yake presented a concept of moving the Association bank account from Bank of America to Bank United and placing a portion of the assets into a money market or CD to earn some interest on funds that are otherwise idle. Discussion was held on the risks of doing so and to the rating of the bank and if the funds would be covered by FDIC.
